Meg Kinnear is a Canadian international disputes specialist. She is renowned for her expertise in investor-State dispute settlement (ISDS), having been the first full-time Secretary-General of ICSID (2009-2024) and head of Canada's in-house international investment and trade law group (1999-2009). Meg has been the lead counsel in numerous ISDS cases, has negotiated international investment and trade treaties, and provided strategic and legal advice on a wide variety of international commercial, investment and trade disputes. From 1984 – 1996, she litigated high profile commercial, administrative and constitutional matters in Canadian domestic courts and tribunals. Her expertise spans numerous sectors, including concessions, construction, energy, finance, infrastructure, mining, natural resources, procurement, tariffs, telecommunications and transportation. Since July 2025 Meg has acted as a dispute neutral, including as an arbitrator (Chair and party-appointee), as a panelist under the USMCA, and in mediations.
